She noted that as per the statement from the Board Chair at the informal meeting of board members, that GCRB remains business as usual while the outcome of the Scottish Government consultation on regional strategic bodies is awaited. She confirmed that GCRB will focus on its stewardship role and statutory functions during this time, rather than initiative any new activity.

#### 6. Glasgow College Region Update 2024-25

#### 6.1 Discussion

The Chair invited the three college representatives to provide and update on recruitment and enrolment for the start of the new academic year for their respective college.

Each representative confirmed a positive start to the year with each college being on track to reach their targets, with demand exceeding availability in many cases. They spoke of a small decrease in HE however this not being significant enough to warrant any concern. The representatives provided assurances that they try to help all applicants, even when spaces aren't available on their preferred course, and do look across the region to suggest alternative options where possible.

# 7 Key Performance Indicators 2023-24

## 7.1 Discussion

The Finance and Resources Director presented the report confirming that the three colleges are forecasting to meet the credit target for 2023-24 therefore there is no risk of clawback at regional or college level.

He confirmed that there will be an audit of the 2023-24 data, this will be submitted to the SFC and this will provide the official final position.

#### 8 Capital Funding 2023-24

#### 8.1 Discussion

The Finance and Resources Director presented the report noting that it is now 6 months past the end of the financial year for this funding. He confirmed that all projects are complete other than one which will roll forward into the 2024-25 funding year.

#### 8.2 Decision

#### 9 Flexible Workforce Development Report 2023-24

#### Paper Number: PRC1-D

#### 9.1 Discussion

The Finance and Resources Director presented the report noting that FWDF funding ended over a year ago and colleges are completing final activity to utilise remaining funds.

He noted that further to the information provided in the paper, City of Glasgow College had advised that they will imminently submit a further claim meaning that the remaining funds noted in the paper will reduce again significantly. He noted that he would estimate therefore that remaining funds may be in the region of less than £20,000.

## 9.2 Decision

The committee **noted**:

- the residual value of flexible workforce funding, to be claimed by the colleges, is £87,137 and is due to reduce further following a further claim from City of Glasgow College; and
- The Finance and Resources Director will provide a further update to the next meeting of this committee with recommendations as to the use of these funds.

#### 10 GCRB Costs 2023-24

#### 10.1 Discussion

The Finance and Resources Director presented the paper noting no surprises for the year end 31 July 2024 and that variances at 3.2 and 4.2 have been reported through the committee.

The Committee noted the end of the Environment and Sustainability project through the Programme of Action and asked how work in this area will be taken forward across the region. The Finance and Resources Director confirmed that the colleges will each progress their activity individually at college level.

#### 11 Capital Funding 2024-25

#### 11.1 Discussion

The Finance and Resources Director presented the paper noting it provides the capital plans for Glasgow Kelvin and Clyde colleges for 2024-25. He explained that it outlines the projects that the colleges are working on and also other sources of funding that may support some of the activity.

The college representatives provided further detail on the substance of the report and provided assurances around health and safety, cladding, sustainability, and planning for use of the entire estate. The committee also discussed digital and the challenges in this area, as well as opportunities for regional curriculum and estates planning.

The Finance and Resources Director spoke to the SFC infrastructure strategy and proposals to the Scottish Government for colleges to retain funding for disposal of assets for reinvestment locally.

#### 11.2 Decision

The committee **noted** the progress made by the colleges in respect of the capital projects in the financial year ending 31 March 2025.

It was **agreed** to include digital and sustainability issues more prominently in future capital reports.

#### 12 Financial Forecast Return 2023-24 – 2026-27

#### 12.1 Discussion

The Finance and Resources Director presented the report noting that the colleges submitted their FFR returns to GCRB at end June 2024. He confirmed that the FFR is based on college budget projections and that colleges will reflect and revise these on an ongoing basis, therefore the information provided is a snapshot in time.

He highlighted that unsurprisingly, the main theme from the information provided, is that income is going to fall and expenditure rise therefore costs needs to reduce. He confirmed that colleges are therefore anticipating a reduction in staff to maintain a balanced budget.

The committee discussed the regional position and individual positions of each institution. They discussed the different approaches undertaken by each college in their financial strategies which tend to align to each colleges' ethos and culture.
