3. Background

3.1 The Scheme of Delegated Authority requires the Executive Director to report to the regular meetings of the Board any decisions he has made under the Scheme of Delegated Authority for amounts greater than £10,000 in relation to:

- Committing funds within agreed budgets;
- Revision of individual budgets for any one year up to a limit of £10,000 or 5%, whichever is the higher; and
- Application of any discretionary budget controlled by the Executive Director.

In addition, delegated authority may be used to exercise decisions via the Scheme of Delegation, and these are reported to board in the separate paper *Decisions via Scheme of Delegation*.

4. Report

4.1 During the reporting period one use of delegated authority should be noted, as follows:

4.2 Additional 12,000 allocation to Bridge 2 Business project within the Programme of Action, directed from savings elsewhere, to provide the Bridge 2 Business + offering across the Glasgow colleges. Details of changes included in appendix for information. The remainder of the Bridge 2 Business funding is provided directly by Scottish Government's Strategic Fund and administered by GCRB.

5.1 The Executive Director is responsible for implementation of the Glasgow Region Strategic Plan for College Education 2017-2022, management of risk and oversight of resources. The use of delegated authority is designed to maintain these positions.

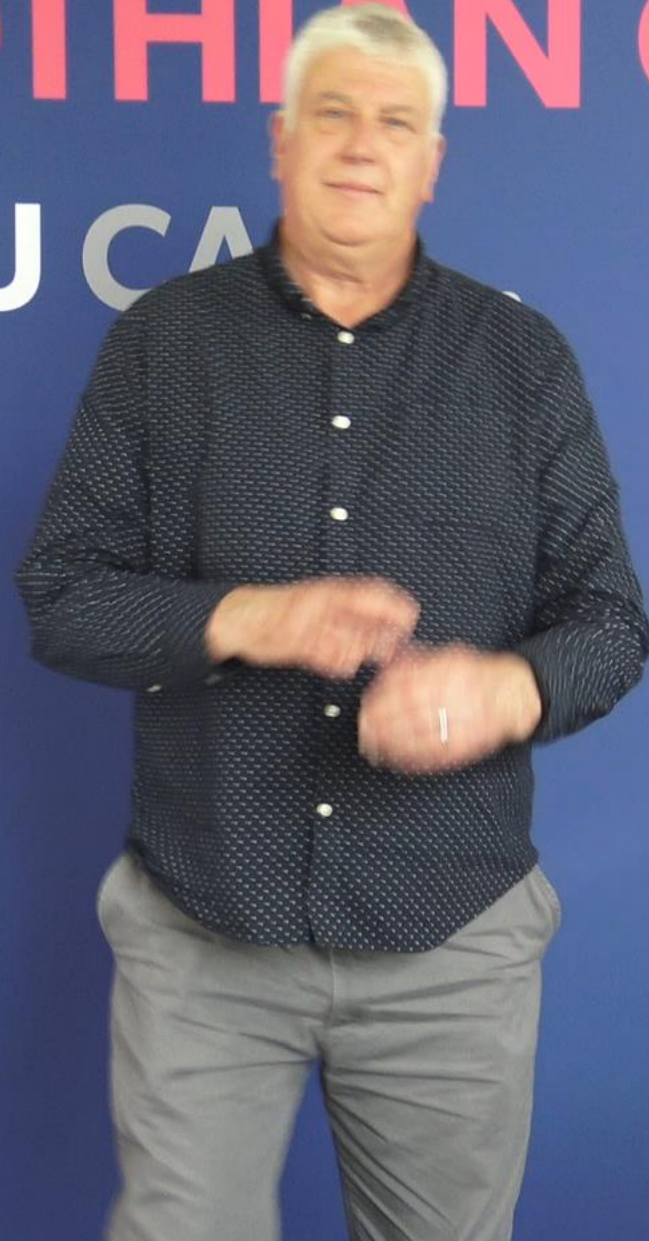
