### 1. Report Purpose

- 1.1. To note the SFC Final Credit Allocations for 2019-20 and the revision of Glasgow Region Credit activity targets.

### 2. Recommendations

- 2.1. The Committee is invited to:

- **note** the final announcement by the SFC of Credit targets for the Glasgow College Region;
- **note** that as the SFC final allocation is only slightly changed from the indicative allocation, the revised Credit targets for the Glasgow colleges remain broadly as agreed by the GCBR Board at its March 25 meeting;
- **note** the additional economic sector and childcare activity Credit targets provided within this report;
- **note** the final 2019-20 Glasgow Regional Outcome agreement, which includes the agreed Regional Programme of action and additional content required to meet SFC requirements; and
- **note** the attached exemplar project specification for a collaborative regional activity committed to within the Regional Programme of Action for 2019-20.

### 3. Final 2018-19 Credit Allocations

- 3.1 On May 16, 2019 the SFC announced final allocations for 2019-20 Regional Outcome Agreement Funding for Colleges.
- 3.2 The final Credit Activity targets college regions are provided for information in Annex A.

**3.3** As shown in the SFC announcement, the Core Credit target for Glasgow remains unchanged, but the ESF target has been reduced by 49 Credits from that indicated in February.

**3.4** The following ESF and Core Credit targets for the Glasgow colleges are therefore proposed for 2019-20:

**3.5** The final SFC announcement also confirmed targets for SCQF level 7-9 Childcare Training Credit Targets. These represent a slight reduction from the 2018-19 targets (from 7,095 to 6,387 Credits). Following discussion with the Glasgow colleges, the region collectively is planning to maintain current levels of childcare activity in response to continuing regional demand.

**3.6** The following Childcare training Credit targets have therefore been set for each college in 2018-19:

**3.7** A primary goal of the Regional Outcome Agreement is to deliver a responsive regional curriculum which meets current and future skills and employment demands, supporting inclusive economic growth and providing learners with the qualifications and skills they need to build successful long-term careers. To enable and support the planning of a regionally coherent curriculum which responds effectively to economic, employment and social needs, the Glasgow regional curriculum has been grouped into eight sectors. Following discussion with the Glasgow colleges, the following sector based Credit targets are proposed for 2019-20.

- 3.8** Members should note that further review of sector based Credit targets for 2020 onwards will form a significant aspect of the planned regional curriculum and resources review.
- 3.9** A spreadsheet containing all regional and college performance targets has been provided to the Glasgow colleges and the Scottish Funding Council and will be published on the GCRB website. This can also be provided to Board members on request.

#### **4 Final 2019-20 Regional Outcome Agreement**

- 4.1** Following agreement of the 2019-20 Regional Programme of Action at the GCRB Board meeting on 25 March, 2019, the GCRB Executive Director drafted the attached ROA document provided at Annex B. This responds directly to the SFC guidance requirements for Regional Outcome Agreements. The final ROA was considered by members of the regional college Learning and Teaching Group prior to submission to the SFC.

#### **5 Risk Analysis**

- 5.1** The ROA addresses directly a number of GCRB's strategic aspirations and therefore the GCRB's risk register addresses a range of associated risks. Of particular relevance is GCRB Risk 008: *Failure to achieve the targets set out in the Regional Outcome Agreement lessens our ability to meet regional needs*. Key mitigation strategies are to enhance the quality and value of performance data, to regularly evaluate outcome performance, and to address areas for improvement through Enhancement Plans within new national quality arrangements.

#### **8 Resource Implications**

- 8.1** Following extensive discussion of resource allocation for regional collaborative projects at the previous meeting of the Committee and at the March 25 Board, the GCRB Executive Director has been liaising with college colleagues and partners on the development of more detailed project specifications for each of the collaborative projects. These specifications will set out project leads, planned outputs and outcomes, critical deliverables, risks and mitigation strategies, dependencies and required resources for each regional project. At least six project specifications will be developed and are currently at differing stages of completion. As the process progresses, opportunities to identify collaborative inputs will be explored with college colleagues and partners. An example of a completed project specification is attached at Annex C for information.
- 8.2** Outcome agreement funding is considered in more detail within another agenda item.

## **9 Strategic Plan Implications**

- 9.1** The Regional Outcome Agreement addresses directly the regional strategic ambition to build Scotland's most inclusive, most responsive and most effective regional college system.
